

Yeo's x FairPrice Exclusive Promotion

Terms and Conditions

Yeo's Contest is organized by YHS (Singapore) Pte Ltd ("Organizer", "we" or "us").

A. ELIGIBILITY

- 1. This Promotion is open to all Singapore citizens, permanent residents, work permit holders and is valid in Singapore only.
- 2. If a Participant is below 21 years of age, the consent of the Participant's parent or legal guardian is deemed to have been obtained. The award of any prizes to such Participants shall be subject to the verification of such consent by the Organizer in our sole discretion, and we reserve our right to not award the prizes in the event such consent is not substantiated to our reasonable satisfaction.
- 3. Employees of the Organizer, our advertising and Contest agencies, affiliates and subsidiaries and their immediate families (spouses, parents, siblings, children and each of their spouses and household members) are not eligible to participate in this Contest.

B. CONTEST PERIOD

C. HOW TO PARTICIPATE

- 1. Spend a minimum of \$5 on Yeo's and/or participating brands in a single receipt ("Proof of Purchase") at any FairPrice outlet during the Promotion Period. Receipts from other retailers other than FairPrice will not be entertained and such entries will be disqualified.
- 2. Submit your entry via SMS to qualify as an entry ('Entry') to the draw ('Draw').

SMS to 9010 2322 in the following format:

YHS <space> FPEXCLUSIVE <space> NAME as per NRIC <Space> RECEIPT NO.

Example: YHS FPEXCLUSIVE BEN ANG R12345

- 3. For each valid entry, an auto-reply SMS will be sent. The SMS will provide an URL for submission of your participating receipt. Take a photo of the receipt and upload image onto the URL provided.
- 4. Each receipt number can only be sent once via SMS, and participate in ONE (1) Promotion or Lucky Draw campaign organized by the Organizer.



- 5. Participating brands include: Yeo's, 100% Coconut Water, H-TWO-O, Juscool, Pink Dolphin, Oceanic, Justea, pH Infinity and Sparkle.
- 6.
